Request-Danny Shepard: Judge Shepard submitted three (3) budget requests for the upcoming fiscal year. The first request was to increase his salary from \$7200 per year to \$9600 per year. On motion of G. Williams and second of R. Williams, Council unanimously voted to approve a \$100 increase from \$600/month to \$700/month (\$8400 per year) provided that we have twelve (12) court sessions per year instead of the eleven (11) court sessions we currently have.
